### SUPREME COURT ACT (CHAPTER 53)

### SUPREME COURT (CIVIL PROCEDURE FEES) RULES, 2023

The Rules Committee, in exercise of the power conferred by section 76 of the Supreme Court Act (Ch. 53), makes the following rules —

#### 1. Citation and commencement.

- (1) These Rules may be cited as the Supreme Court (Civil Procedure Fees) Rules, 2023.
- (2) These Rules shall come into operation on the  $1^{st}$  day of March, 2023.

#### 2. Fees of Court.

- (1) The fees set forth in Part A of the *Schedule* shall be the fees of the Court to be payable at the commencement of any cause, matter or proceeding brought under the Divisions of Court.
- (2) Any person desirous of making an application to the Court as an indigent person, may request a waiver of fees provided that
  - (a) the person has a reasonable cause of action or defence; and
  - (b) the person makes an oath in the form set out in Part B of the *Schedule*, attesting that the person is unable to pay the fees for the requisite application made to the Court.
- (3) No fees shall be payable by the Crown, the Attorney-General, the Director of Public Prosecutions, the Office of the Public Defender or the Commissioner of Police.
